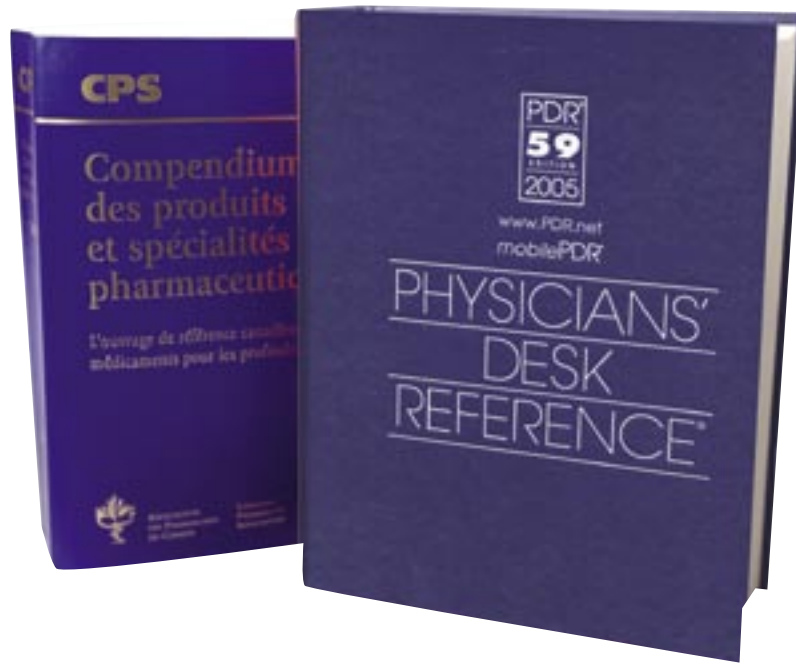

**ADVANTAGES**
